ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

Offer Price and net proceeds from the Share Offer

- The final Offer Price has been determined at HK\$0.84 per Offer Share plus brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%.
- Based on the final Offer Price of HK\$0.84 per Offer Share and 155,000,000 Shares offered by the Company, the net proceeds from the Share Offer, after deducting the underwriting commissions and other expenses in connection to the Share Offer, are estimated to be approximately HK\$96.7 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future plans and use of proceeds” in the Prospectus.

Applications under the Public Offer

- The Offer Shares initially offered under the Public Offer have been moderately over-subscribed. A total of 14,575 valid applications were received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS, for a total of 174,317,500 Public Offer Shares, representing approximately 11.25 times of the total number of 15,500,000 Public Offer Shares initially available for subscription under the Public Offer.
- In view of the over-subscription in the Public Offer, the Sole Bookrunner has, on its discretion, exercised the reallocation procedures as described in the section headed “Structure and conditions of the Share Offer — The Public Offer — Reallocation” in the Prospectus. A total of 15,500,000 Offer Shares have been reallocated from the Placing to the Public Offer. As a result of such reallocation, the final number of Offer Shares allocated to the Public Offer has been increased to 31,000,000 Offer Shares, representing 20% of the total number of Offer Shares available under the Share Offer, and being allocated to 5,451 successful applicants under the Public Offer.
